



PLEASE READ THE FOLLOWING:

IN CONSIDERATION OF AND AS AN INDUCEMENT TO ENROLLING AS A STUDENT OF YOGA TREE PERTH (YTP) – UNIT 1, 345 SHEPPERTON ROAD, EAST VICTORIA PARK, WA 6101.

I REPRESENT AND AGREE AS FOLLOWS:

1. I have been examined by a licensed doctor within the past 6 months and have been found by such doctor to be in good health and fully able to perform all yoga exercises which I am to learn and perform during my enrolment with you. I represent and warrant that I have no medical condition or injury which would prevent me from fully participating in Bikram Yoga. Any impairment I have I will disclose to you in writing.
2. I understand that it is my continuing responsibility to inform the teacher(s) at YTP of any previous or current medical conditions, injuries or surgeries prior to each class.
3. I will faithfully follow all instructions given to me by your teachers as to when, where and how to perform and not perform the yoga postures (exercises). It being understood that any deviation by me from such instructions shall be at my own risk.
4. I understand and acknowledge that I am to receive instruction in yoga theory and exercises only and I will not hold you, your partners, teachers or employees to any higher standard of care than that applicable to a school of yoga theory and exercises.
5. These classes entail intensive physical activity (conducted in a heated room – approximately 40 degrees celsius) and exertion by me. I recognise that such physical activity and exertion may be difficult and strenuous and may cause or aggravate a physical injury to medical condition. I assume full responsibility for any risks, conditions, injuries or damages, known or unknown which I might incur or aggravate as a result in participating in Bikram Yoga.
6. In future consideration of being permitted to participate in Bikram Yoga at YTP I knowingly, voluntarily and expressly waive any claim I may have or acquire against Bikram Yoga for any injury, condition or damages that I may sustain as a result of entering or being on the premises or participating in Bikram Yoga at YTP.
7. My heirs and legal representatives forever release, waive, discharge and covenant not to sue Bikram Yoga and YTP for any injury, condition, or death which arises if caused by or is aggravated by reason of my participation in Bikram Yoga.
8. The tuition paid herewith and any fees paid hereafter are non-refundable and non-transferrable. Refunds, if any that are made shall be entirely at the discretion of YTP in writing.
9. YTP reserves the right to refuse access. I also understand that except for a monetary refund of class paid that I have no claims against Bikram Yoga and YTP by reason of their refusal to allow me to participate in the practice of Bikram Yoga.
10. I understand and acknowledge that YTP is not responsible for any loss, theft or damage to personal property left on its premises.
11. I agree to abide by YTP's terms and conditions, including operational rules which may be displayed in various parts of the premises and website. YTP reserves the right to make amendments to these terms, conditions and rules. I understand that if I do not comply with these terms and conditions and operational rules that I may be denied access into its premises.
